3. Practiced experience in arbitration

How many arbitrations have you participated in (domestic/international)? Under which Rules?

- Czech Republic: under the Rules of the Arbitration court attached to the Economic Chamber of the Czech Republic and the Agrarian Chamber of the Czech Republic (both domestic as well as international disputes), as of yet 507 cases (as co-arbitrator, chairman or as sole arbitrator). Currently non available exact statistics, but aprox. 1/3 of the number above international disputes and 2/3 domestic disputes. From the number above currently 4 cases pending.
- **Czech Republic:** *ad hoc* **under UNCITRAL Rules** 8 cases, 3 as chairman, 5 as co-arbitrator
- **Czech Republic:** *ad hoc* out of any specific Rules just pursuant to Czech Act on Arbitration **21 cases**: 8 of them as chairman, 9 as co-arbitrator, 4 as sole arbitrator
- **VIAC** VIAC Rules: **6 cases** as co-arbitrator or sole arbitrator
- **ICC**: **8 cases:** 2 as chairman, 1 as sole arbitrator, 5 as co-arbitrator (one case pending)
- **Lithuania**: Rules of the permanent arbitral institution attached to the Chamber of Commerce and Industry 1 case as co-arbitrator.

- Ukraine: 7 cases: (i) ad hoc under UNCITRAL: 1 as chairman, 3 as co-arbitrator; (ii) Rules of the International Court of Commercial Arbitration attached to the Ukrainian Chamber of Commerce and Industry: 3 cases as co-arbitrator
